General Energy Law: Andorra regulates its energy sector primarily through the Law 14/2014, of December 12, on the regulation of the electricity sector and related energy matters. Energy policies in Andorra are shaped by the country's geographic and political context, being landlocked and dependent on Spain and France for energy supplies. The legal framework aims to ensure a secure, sustainable, and efficient energy supply, with attention to renewable. Andorra's energy production regulations have evolved over the years in order to accomplish international standards and goals. In the medium term it will help. According to the Organization of Consumers and Users (OCU) the average total bill in Spain has been 949 euros, which is 41% more than the 2020 bill (675 euros), and 18% more than the 2018 bill, to which the Government had promised not to exceed. 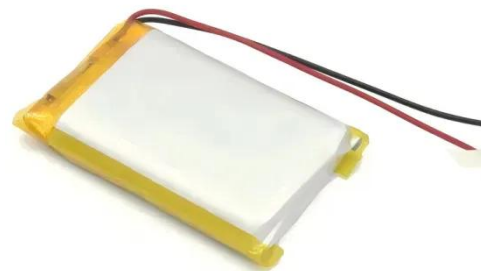
