System operator ISO New England has given the go-ahead for a 300MW/1,200MWh indoor BESS located in Boston, Massachusetts under development by developer and IPP Flatiron Energy. ISO New England approved a proposed plan application associated with the project in the form of a letter published on the. Plus Power's 150 MW / 300 MWh facility will strengthen the reliability of the regional grid CARVER, Mass. 10, 2025 /PRNewswire/ -- Plus Power announced it is now operating its Cranberry Point Energy Storage facility in Carver, Massachusetts, the largest utility-scale standalone battery. Battery energy storage system (BESS) developer Plus Power announced the close of term financing for the Cranberry Point Energy Storage facility, which will be the second largest energy storage facility in Massachusetts and provide capacity and stability to the Independent System Operator of New. Trimount ESS LLC (the "Company") filed petitions with the Energy Facilities Siting Board ("Siting Board") seeking: (1) approval to construct, operate, and maintain two underground transmission lines, one at 115 kilovolt ("kV") and one at 345 kV; and (2) individual and comprehensive zoning. Plus Power has announced the close of construction and term financing for the first major utility-scale standalone battery storage system in construction on the New England grid, among other firsts for standalone storage in the region.

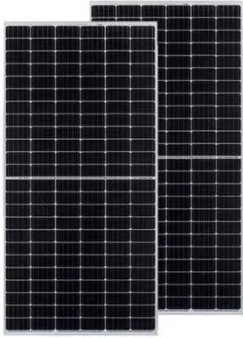

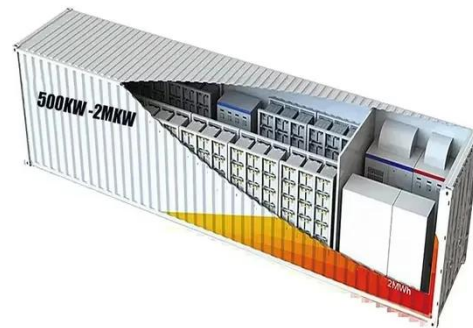
