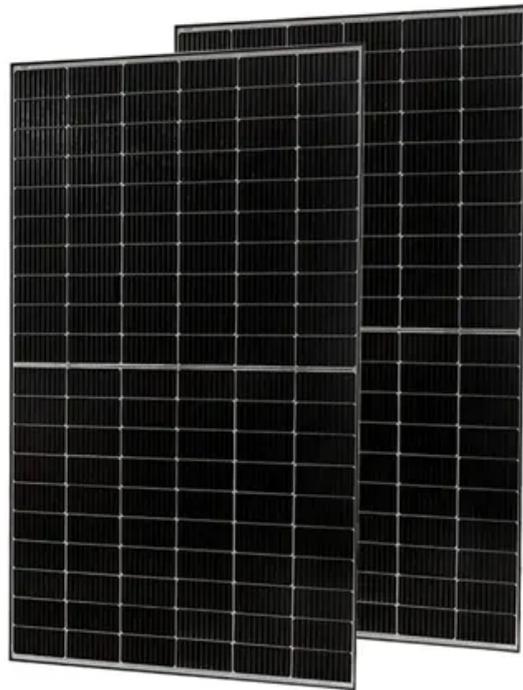


# How to stop parents from installing photovoltaic panels

Instead, create rules that specify preferred locations for solar panels; require the solar panels to be painted or otherwise screened from view; limit the total amount of roof space utilized; or establish a preferred distance for solar panels above roof tiles. Solar panel conflicts typically involve disputes between homeowners, neighbors, and HOAs over aesthetics, shading, and installation restrictions in residential communities. Most states provide legal protections for solar installations while allowing reasonable restrictions, and conflicts can be. Before you object to a neighbor's solar panels, understand the balance between individual property rights and broader renewable energy regulations. The answer to that question depends on where you are geographically and chronologically. This could effectively prevent owners from installing solar panels outright, making it unlawful and unenforceable. Homeowners associations have been a historic friction point. Luckily, many states have passed.



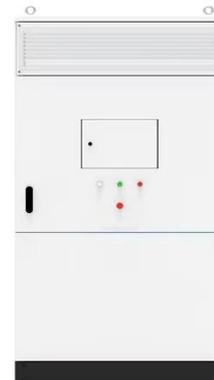

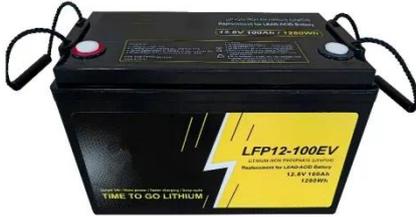
