This calculator is designed specifically for insurance professionals—particularly adjusters—who need practical, field-tested depreciation estimates for a wide range of items across various categories. For tax years beginning in 2024, the maximum section 179 expense deduction is \$1,220,000. See Dollar Limits in chapter 2. For instance, a widget-making machine is said to "depreciate" when it produces fewer widgets one year compared to the year before it, or a car is said to "depreciate" in value after. Section 167 of the Internal Revenue Code defines "depreciation deduction" as a reasonable allowance for the exhaustion, wear, and tear (including a reasonable allowance for obsolescence) of property held for the production of income. The cost of a productive facility is one of the costs of the services it renders during its useful economic life. Examples of assets that may qualify for this depreciation class.

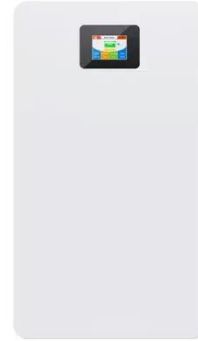
