To facilitate the installation of photovoltaic systems, an agreement is reached between property owners and solar energy companies. Contracts often last 20 years or more. You don't buy the system or own anything installed on your property. During the term of the contract, you're entitled to use all the power the system produces. You'll probably buy less power from your electricity. Renting your roof for solar is a way to generate additional income with minimal effort on the part of the property owner. All that is required is suitable unused roof space capable of housing solar panels. Can you rent solar panels?

We've established that you can lease solar panels like you would a car: But what about renting?

Car leases and PPAs work similarly.

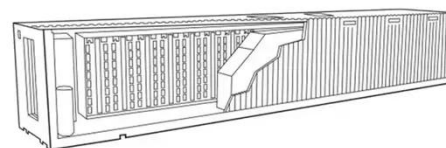
