Chinese PV provider Skycorp Solar Group has announced a solar plant acquisition and development strategy following. Nofar USA, a subsidiary of global independent power producer Nofar Energy, is the successful bidder for the acquisition of a 979-MW utility-scale solar portfolio developed by Pine Gate Renewables, pending approval from the U. Bankruptcy Court for the Southern District of Texas, Houston Division. A federal judge approved the asset sale this week following a bankruptcy auction for the Oregon solar and storage site.
